

APPLICATION TO PLAY THE AIR GAME

Waiver of liability and release of liability



1. I, the undersigned wish to play the air gun game (hereinafter referred to as the Game). I recognize and understand that by playing the Game I could become injured in many different ways. Those risks include, for example but not limited to , the risk of injury resulting directly, or indirectly from the impact of the paint pellets used in the Game injuries resulting from tripping or falling, injuries resulting from possible malfunction of equipment used in the game, injuries from defects in the equipment used in the Game or in the playing field, injuries from equipment that may be considered unreasonably dangerous or unsafe and injuries resulting from any action taken by the air gun game operator (hereinafter referred to as the Sponsor). In addition, I recognize that I may suffer injuries even if I am playing the Game in accordance with the rules of the Game as set forth by the Sponsor or from overexertion in playing the Game. I recognize that these injuries could be serious, including by example and not limited to, loss of sight or even death.
2. I have read and fully understand Paragraph 1 and the risk of injury described in Paragraph 1. I still wish to play the Game. I understand that by signing this application to play the air gun game. I release, discharge and agree to hold harmless and indemnify the Sponsor and the sponsor's employees, agents, representatives, successors, and assigns from any and all liability of any kind or nature including, but not limited to, liability for injuries from the hazards or dangers described above from any and all claim including for example, but not limited to claims for negligence, strict liability and others, actions, suits, procedures, costs, expenses (including attorney's fees and expenses), damages and liabilities arising out of , connected with or resulting from my playing the Game including without limitation those resulting from the manufacture, selection delivery, possession use or operation of the equipment or from and acts or omissions of the Sponsor or Sponsor's employees even if such acts constitute negligence or misconduct. I hereby release the Sponsor from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsor that I am in good health and do not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in playing the Game.
3. I hereby promise to play the Game only in accordance with the rules of the Game as set forth by the Sponsor, and state that I am eighteen years of age or under eighteen years of age and my parents or legal guardian have read and signed this waiver on my behalf.
4. I also agree that Paintballs used at Prairie Wars Paintball must be purchased at Prairie Wars Paintball and that Paintballs bought from a different vendor will not be used at this location.
